

MBBS / BDS ADMISSIONS Government Medical Colleges of Azad Jammu & Kashmir (AJ&K) and Reserved Seats for AJ&K Nationals in Pakistan, Session 2023-2024

Applications are invited from eligible (First Class State Subject) candidates for admission to First Year MBBS and BDS against reserved seats for AJ&K Nationals, Refugees 1947 and Refugees 1989 (*conditions apply*), in the Public Sector Medical/Dental Colleges of Pakistan (Punjab, Khyber Pakhtunkhwa, Balochistan & Sindh) and Public Sector Medical Colleges of AJ&K. Admissions will be made strictly on merit basis as per Admission Policy of AJ&K Government in vogue. 1. ELIGIBILITY CRITERIA

- i) The applicant has passed HSSC/ F.Sc. (Pre-Medical) or equivalent examination with minimum 60 per cent (660/1100) marks. All applicant mention their Total Marks and obtained marks.
- ii) The applicant has passed the National MDCAT-2023, with minimum 55 percent for MBBS and 50 percent for BDS. All students, must have qualified the MDCAT 2023. The result of MDCAT-2022 is no longer valid for seeking admission in session 2023 which was already mentioned on the individual result certificates. Provided that the mandatory requirement of MDCAT shall not apply to students seeking admission on a special program seat predefined exclusively for foreign students and on the seats reserved for overseas Pakistanis. Such students shall qualify SAT-II with minimum score of 550 in each subject or a foreign MCAT examination or UCAT examination with 50% marks in the subjects as prescribed in PM&DC Regulation.

2. MERIT CALCULATION:

(i) The weightage criteria for calculation of Aggregate Percentage will be as follows:

SSC/Matriculation/Equivalent	-	10%
HSSC/F.Sc. Pre-Medical/ Equivalent	-	40%
MDCAT	-	50%

3. ADMISSION PROCEDURE:

a. Online Application Process:

- (i) The application process shall be completely online and no manual or paper-based application shall be accepted.
- (ii) For filling the online application form, the candidate shall have to first register on the web portal at <u>https://mcadmissions.admin.gok.pk/login</u> using his/her -mail ID and a password.
- (iii) Once the candidate has logged in, he/she will enter his / her profile information (Name, Domicile, Marks, etc.). After making all entries,

the candidate will be required to upload his/her scanned mandatory original documents (State Subject Class-I, Domicile, PRC, CNIC, differently abled persons Certificate in case of any Differently Abled, photograph, signatures, left thumb impression (LTI) and Challan as per the list provided on the website.

Note: Refugees 1947 and 1989 are exempted from Permanent Residency Certificate (PRC).

Refugees 1989 are exempted from Domicile Certificate; they are required to up-load Refugee Card in place of Domicile.

- (iv) Order of Preference for Colleges: Every applicant is required to list the medical and dental colleges in order of preference, starting with his/her first choice. All colleges' preference choices are mandatory. The order of preferences once given shall be final and cannot be changed subsequently.
- (v) Before final submission the candidates are directed to please recheck their quota / category against which they desire to get admission (eg. District Quota, Self-Finance, Overseas, Differently abled persons, Special Seats for Neelum or Leepa Valley and BDS)
- (vi) After the final submission, the applicant will not be able to edit his/her application.
- (vii) Students with Differently abled persons must tick the relevant box in the application and upload the required documents. E-mail shall be sent on the E-mail ID of the candidate.

b. Submission of Processing Fee:

(i) On final submission, the candidate print pay pro ID and deposit Admission Processing Fee of Rs. 3000/- and I.T charges of Rs.400/- (both non-refundable), through Easy Paisa Shop/Debit Card/online bank, after which the application process will be completed.

5. <u>IMPORTANT:</u>

- Candidates having different abilities are directed to appear before the specialist of their different abilities one-day advance (i.e 1st November 2023) of the schedule date disability board held at respective hospitals (i.e CMH and AIMS)
- (ii) After notification and communication of decision of the Disability Board, appeal against the decision of Disability Board could be made to the Secretary Health, within five working days. No appeal shall be entertained thereafter.
- (iii) Any candidate found to have submitted forged/fake/fabricated documents or incorrect/false information shall be debarred from admission for a period of 7 years.
- (iv) Candidates are advised to enter their correct and active cell number and e-mail in their applications.
- Incomplete applications or those submitted in violation of the prescribed procedure shall be rejected. It shall be the responsibility of the candidate to submit complete application as per the given instructions.
- (vi) Candidates having foreign qualifications such as A/O Level, etc., shall have to upload the Equivalence Certificate issued by IBCC otherwise their applications shall be rejected.
- (vii) The selected candidates are directed to deposit their original SSC & FSc Certificate/Result Card to the concerned college duly attested by IBCC.
- (viii) The scan copies of original required documents must be upload, scan copy of any photo state documents are not acceptable.
- (ix) Receipts of documents under-preparation (e.g., State Subject, domicile, PRC, equivalence Certificate, etc.) shall not be acceptable.

- (x) The Mangla dame effectives applied against Refugee 1947 quota must be upload the proof duly signed by commissioner Mangla regarding Mangla dame effectives.
- (xi) No separate call letter will be issued to any candidates for Medical Board, persons having different abilities.
- (xii) Candidates is requiring to upload MDCAT results received from PM&DC.
- (xiii) After the last date of submission of application, MDCAT Result, board results, increase in marks, any other document, shall not be acceptable.
- (xiv) As per Admission Policy GoAJK, any candidate (AJ&K State Subjects), who is selected on Open Merit of any public sector medical college of Pakistan, shall avail that seat. He / She will not be eligible for AJ&K seat. If any violation found out, after admission, his/her admission will stand cancelled from the date of admission.
- (xv) The candidates declared successful for admissions in Medical Colleges of Azad Jammu & Kashmir and those of Pakistan, will submit their willingness on judicial stamp paper (Rs.100/-), within notified time period. Admission of those candidates, who fail to accordingly submit their willingness, will stand cancelled and the next candidate from the merit list of the concerned district/category/unit, will be admitted in their place.
- (xvi) No candidate shall be eligible for foreign quota seats in the public and private medical and dental institutions unless, he holds a permanent foreign nationality or is on overseas (being a Pakistani citizen permanently resident in a foreign country) Pakistani , and who has studied and passed HSSC 12th grade examination or equivalent from outside Pakistan and is a resident of a foreign country at the time of applying for admission and possess a certificate from the institution last attended to this effect.
