Azad Jammu & Kashmir Medical College Muzaffarabad invites sealed bids from Sole Agents, Proprietors Manufacturers and authorized Suppliers registered with income tax/sales tax department Government of Pakistan/AJ&K for the procurement of Furniture items on F.O.R Muzaffarabad basis. The quotations will be received till 10:00 AM on Mar 2025 in the office of undersigned and will be opened on same day at 11: 00 AM at AJ&K Medical College Muzaffarabad by the Purchase Committee for AJ&K Medical College Muzaffarabad under AJ&K PPRA Rules 2017 on Single Stage Single Envelope Basis.

Terms and Conditions:

1. Item / unit wise rate of all items must be entered.

2. Bid must be accompanied by Rs. 100000/- (Rupees One Hundred Thousand Only) as bid security (Call Deposit); otherwise bid will not be entertained; failure to do so shall amount to disqualification.

3. Bid documents are available after this publication and may be obtained upon payment in cash Rs. 1000/- (non refundable) against written request from the office of AJ&K Medical College Muzaffarabad during working hours up till Mar 2025.

 Date and Stamp of the firm must be entered on sealed bids. Incomplete bids will not be entertained.

The offered rates will be applicable from date of issuance of supply order to till completion of supply by the supplier and no request for enhancement of rates will be accepted.

The supply will be made within the time specified in the Supply Order.

 After delivery of consignment Inspection Committee will inspect the items according to the specification and if it is not accordingly, the supply will be rejected and lifted by the firm at its own risk and cost.

8. Quoted rates must be inclusive of GST; rates exclusive of GST will not be entertained.

 All taxes/duties levied in AJ&K will be deducted from the total value of the bill at the time of the payment.

Black listed and banned Companies /Firms /Suppliers/Contractors/Bidders are prohibited for participation and all bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with Govt. in any where in territory of the AJK, federally administrated areas or Islamic Republic of Pakistan.

11. Catalog/Drawings of quoted items must be provided by the firm with the bids.
