Azad Jammu & Kashmir Medical College Muzaffarabad invites sealed bids from Sole Agents, Proprietors, Manufacturers and authorized Suppliers registered with income tax/sales tax departments Government of Pakistan/AJ&K for repair / maintenance of buses (specifications and other instructions are written in the Tender Document). The quotations will be received till 10:00 AM on 11 Mar 2025 in the office of undersigned and will be opened on same day in the presence of authorized representative at 11:00 AM at AJ&K Medical College Muzaffarabad by the Purchase and Negotiation Committee for AJ&K Medical College Muzaffarabad.

Terms and Conditions:

1. Supplier must quote rate with specification separately.

- 2. Bid must be accompanied by 100000/- (Rupees One Hundred Thousand only) as bid security (Call Deposit/Bank Guarantee); otherwise bid will not be entertained.
- 3. Bid Documents are available after this publication and may be obtained upon payment in cash Rs. 1000/- against written request from the office of AJ&K Medical College Muzaffarabad during working hours up till 07 Mar 2025.
- 4. Date and Stamp of the firm must be entered on sealed bids. Incomplete bids will not be entertained.
- 5. The offered rates will be applicable from date of issuance of order to till completion of work by the supplier and no request for enhancement of rates will be accepted.
- 6. The work will be completed within the time specified in the Supply Order.
- 7. After completion of work / maintenance, Inspection Committee will inspect the work done according the specification and if it is not accordingly, the work done/repair maintenance will be rejected and re-repair/maintenance will be done by the firm at its own risk and cost.
- 8. Quoted rates must be inclusive of all taxes; rates exclusive of taxes will not be entertained.
- 9. All taxes/duties levied in AJ&K will be deducted from the total value of the bill at the time of the payment.
- 10. At least 01 year free service will be the responsibility of the successful bidder.
- 11. Specimens/catalog of material which will be used for repair/maintenance of seats & roof of buses (Leatheride sheet, Foam & GI Sheet) must be attached/provided with bid documents.
- 12. Black listed and banned Companies /Firms /Suppliers/Contractors/Bidders are prohibited for participation and all bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with Govt. in any where in territory of the AJK, federally administrated areas or Islamic Republic of Pakistan.
- 13. Incomplete/conditional bid and bid bearing cutting/over writing without authentication will not be considered.
- 14. The committee reserves right to accept or reject any or all bids as per AJ&K PPRA Rules.
